



Illinois Tax Credit Scholarship Program MyTax Illinois.Gov – Activate Your Account

The **Illinois Tax Credit Scholarship Program (*Invest in Kids*)** will help students who would otherwise not be able to attend Christian Heritage Academy through redirecting your State of Illinois income tax liability. To take advantage of this opportunity, you will need to use the mytax.illinois.gov website to apply for the tax credit on January 2. The steps below provide instructions for signing up and activating your account once you receive your Letter ID, the first step toward getting an account. Step 1: Log on to mytax.illinois.gov and click on “Sign Up Now” on the lower left.

Step 2: Select SSN and enter your Social Security Number and click submit; then click “Yes” to begin activating your account. Enter your Letter ID and either your Individual IL Pin or your most recent Adjusted Gross Income (AGI). If you choose your IL Pin click on “Look up my IL PIN” and go to Step 3. If you choose your Adjusted Gross Income, go directly to Step 4.

Step 3: If you choose to look up your Individual IL Pin click on “Look Up My IL PIN”. Enter your SSN and either your IL Driver’s License or your most recent Adjusted Gross Income. Click “Conduct Inquiry”. COPY your IL PIN and click “Back”.

Step 4: Enter your Letter ID and IL PIN or Adjusted Gross Income (AGI), and when the screen expands, enter your contact information, username and password, security questions and answer, and your email and password.
